## **2019 Assessment Information**

To maintain fair and equitable assessments, the Village of Brooklyn has implemented a Market Revaluation Assessment process, meaning all assessments will be brought to market value in 2019. This ensures all property owners are paying their appropriate share of property taxes. The last time assessments were brought to market value was five years ago in 2014 when a revaluation was completed. In that five-year time period between revaluations, the market value of residential property has changed greatly.

The assessment value is just one of many variables used to determine property tax rates. A change in your property's assessed value does not necessarily indicate an increase or decrease in the amount of property taxes you will pay. However, it does reflect the most recent market value of your property and helps to ensure all property owners are paying their appropriate share of taxes to support local school, technical college, county and municipal government services in our community.



## **FREQUENTLY ASKED QUESTIONS**

### **1. What is a revaluation?**

A revaluation is an update of all assessments in a municipality conducted by Accurate Appraisal, LLC. The assessor is a State certified individual whose duties are to discover, list and value all taxable real property in the municipality, in a uniform and equitable manner. The assessor is not involved in the collection of property taxes.

### **2. Why is the revaluation necessary?**

This ensures all property owners are paying their appropriate share of property taxes. The last time assessments were brought to market value was five years ago in 2014 when a full revaluation was completed.

### **3. Will my property values change?**

Most likely - yes! Some neighborhoods and property types may have increased in value and others may have remained the same. One purpose of a revaluation is to make sure that the assessed values reflect the changes that have occurred in property values.

### **4. Will the assessor need to view the inside of my property?**

The assessor will only view properties that changed from the previous year, this includes, new construction, property splits, and properties that were issued a building permit during 2018.

### **5. How can my assessment change when I haven't done anything to my property?**

As property values change in the marketplace, those changes must be reflected on the assessment roll. Economic conditions such as recent home sales in your neighborhood, sales of reasonable comparable buildings, and inflation will influence the value of your real estate.

### **6. Will I be notified if there is a change in my assessment?**

The State of Wisconsin State Statutes require that all property owners be notified if there is a change in the assessed value of their property.

### **7. What if I don't agree with my assessment?**

Once you have received your value change notice, you can schedule a meeting with the assessor for Open Book. During this informal session, the assessor will explain how your assessment was prepared, view the property record for your property, what factors were considered in determining a value for your property and view comparable house values.

### **8. What if, after this informal meeting, I still disagree with the assessment?**

You can arrange to appear before the Board of Review. To do so, you will be required to complete an objection form, which must be completed in full. You will then be scheduled for a hearing where you will present your case regarding the assessed value of your property.

### **9. What evidence do I need to present to the Board of Review?**

The best evidence of value is the recent sales price of your property (To ensure an accurate assessment of your property, it is to your advantage to allow the assessment personnel inside your property when an inspection is requested.) By denying an inspection, you lose your right to appeal your assessment to the Board of Review.

### **10. What if there hasn't been a recent arm's-length sale of my property?**

The next best evidence is the arm's-length sales of reasonably comparable properties. These are properties like yours in location, age, style, condition, and other features that affect market value, such as the number of bathrooms, bedrooms, and size of garage.

# 11. How will my taxes change as a result of a new assessment?

Though the value of your property affects your share of taxes, the actual amount you pay is determined by the budget needs of the schools, city, county, technical college and state. All these taxing units decide what services they will provide in the coming year and how much money they will need to provide those services.

## ASSESSED VALUE VS. FAIR MARKET VALUE

**Assessed Value:** This is the dollar value placed on a parcel of property by the Assessor. It is computed by analyzing individual sale transactions and inspections of property within the municipality. This value is important because it establishes and maintains equity between and among all taxpayers in the municipality. This is the value that is used to calculate your tax bill.

**Estimated Fair Market Value: (a.k.a. Equalized Value)** This value estimate is determined by the State of Wisconsin - Department of Revenue. It is used to apportion tax levies among municipalities and is used in the distribution of shared revenues. State law requires that assessors be within 10% (higher or lower) of the State's Fair Market Value.

**Brooklyn Village Board Meeting Minutes**  
**April 8, 2019**

The April 8, 2019 Village Board meeting of the Village of Brooklyn was called to order at 6:30 p.m. at the Brooklyn Village Hall by President Todd Klahn. Trustees present were Heather Kirkpatrick, Brit Springer, Sue McCallum and Kyle Smith. Scott Rosenow was absent. Also present were Public Works Director Leif Spilde and Clerk-Treasurer Linda Kuhlman. All present stood for the Pledge of Allegiance. No public comments.

**Smith made a motion to approve the minutes of 3/25/19.** Springer seconded. Motion carried.

**Smith made a motion to approve the minutes of 4/2/19.** Springer seconded. Motion carried.

**Public Works/Utility/EM report** – Residents stopped running water on 3/27. Consumer Confidence Report will be in this month's newsletter as required. The report shows testing for water quality, which is good. Wednesday is the preconstruction meeting for WWTP. Had a conference call last Friday with new property owners for potential trade. It sounds positive. They are in favor of the trade. They did soil samples today. Tomorrow we will have 12 reps from Costa Rica, UW and DNR here to do a plant tour at 1 p.m. They will do pictures and a press release. Had high flows March 11. Gas detectors were replaced. Siren will possibly be fixed this week; only one company that does the work. Local vendor did not submit bid for the Toolcat replacement, so will proceed with one that was approved by board. Pumped Lincoln Street pond on 3/21 and 3/22. Green County supervisor said they're not sealcoating Highway 92 this year. Rented grinder for stumps instead of contracting out the work. They rolled all areas to be mowed and are working with Sno-Hornets to finish up Legion Park. Park bathrooms are open and were vandalized last night. Did a walkthrough of S. Kerch Street and marked-spots in the curb to be replaced, one manhole slid. They have a punch list for the contractor. Do not have a date yet for when they'll be here. McCallum asked if we've heard anything about flooding at 14 and 92. Spilde hasn't heard anything. He checks the storm water infrastructure periodically. Had the preconstruction meeting for the BBC stormwater pond. They are starting April 15 and will be done by May 6. Clay samples were taken today to Giles.

**Summer seasonal employee** -- Spilde stated it takes about 25-30 hours per week to mow all Village grounds. We used Oregon Correctional inmates up until 2017 when they stopped the program. We hired a student last year. He worked 260 hours last year in just under 3 months. Public Works has a list of projects that need to be done, so having the seasonal help will allow the PW employees to do those projects. The seasonal employee is in the budget for this year. He will also drag the diamonds in the park. He would start mid-June after school gets out through August. The student is interested in coming back this year and knows what to do so there will be no training time. He would have done a school-to-work program if we have one and wants to get into Public Works when out of high school. **McCallum made a motion to approve hiring Public Works summer seasonal employee at \$10 per hour for 260 hours.** Smith seconded. Motion carried.

**Clerk's report** – A resident on **Douglas Drive** called asking if there is anything the Village can do regarding the high level of water in the pond. It is halfway up their backyards. He has a young daughter and is worried about insects and also water going into his basement. McCallum stated it's federal wetland and the area was built around it correctly. This was looked at in the past numerous times. Spilde stated in the past the village attorney recommended not doing anything to not set a precedent. The easiest possible option is to pump to a different watershed by pumping to Lincoln Street pond and pumping from there, but he doesn't know if pumping would even help due to the size of the pond. It would be very expensive, and we would need to get permission from the DNR. McCallum and Klahn said they looked at various situations in the past and found no feasible possibilities. The residents could build berms. When the development was put in, there was no change as to what water flows into there. The water table is high all over right now due to the flooding from last year and this winter. The ground is saturated so there is nowhere for the water to go. McCallum will call the resident.

Total deposits for March were \$87,574.18. Total withdrawals were \$132,351.06. **For a total in all accounts of \$1,675,337.48.** In answer to questions at the March 25 meeting regarding bills, Alliant did miss three accounts with taxes, so they will be refunding the taxes paid back to January; Charter/Spectrum's federal excise tax is required by everyone; and a cover letter was sent along with the Traffic Violation and Registration Program check. **The Brooklyn Fire/EMS card party is this weekend, April 13.** Kirkpatrick and Springer are registered for the **GCDC annual meeting on April 24.** **Dane County Breakfast on the Farm** will be held at Klondike Farms this year on June 8 right outside of Brooklyn. The representative will be coming to the next meeting. **McCallum made a motion to send the clerk to the LWMMI policyholder conference in Wisconsin Dells on May 8 and 9.** Kirkpatrick seconded. There is no charge, nor hotel costs, for a representative from the municipality to attend. Motion carried. **Smith made a motion to approve both the clerk and deputy clerk to attend the Dane County spring clerk training on May 9 from 1:30 to 4:30 p.m. at a cost of \$17 each.** Springer second. Motion carried.

Klahn read Resolution 2019-03 into the record. **McCallum made a motion to approve Resolution 2019-03, Wisconsin Public Employers' Group Health Insurance Program, Existing Employer Update Resolution.** Smith seconded. Motion carried.

**Kirkpatrick made a motion to approve Planning & Zoning Commission meeting minutes from 12-18-18.** Klahn seconded. Motion carried.

Springer and Kirkpatrick reviewed the bills. **Kirkpatrick made a motion to approve bills as presented.** Klahn seconded. Motion carried.

McCallum asked why the PW garage repairs account is over budget already. Kuhlman explained the overheard garage broke. McCallum asked why we're at 60% already in the street light utility account. Kuhlman explained that includes the charge for replacing the street light by the gazebo that was involved in an accident last year. We have received reimbursement payment from the company who hit the light.

**Smith made a motion at 7:04 p.m. to adjourn.** Kirkpatrick seconded. Motion carried.

**Brooklyn Village Board Meeting Minutes**  
**April 30, 2019**

The April 30, 2019 Village Board meeting of the Village of Brooklyn was called to order at 6:30 p.m. at the Brooklyn Village Hall by President Brit Springer. Trustees present were Todd Klahn, Heather Kirkpatrick, Sue McCallum and Scott Rosenow. Kyle Smith and Pat Hawkey were absent. Also present were Katie Varney, Kevin Klahn, Erica Klahn, Brad Pernot, Brendan McGrath, Chic Gladding, Dean Pernot, Shirley Pernot, Chief Engelhart and Clerk-Treasurer Linda Kuhlman. All present stood for the Pledge of Allegiance. No public comments.

**Katie Varney with Dane County Breakfast on the Farm** -- Kevin and Erica Klahn are hosting this year at their grain facility on Highway 92 outside of Brooklyn. It's put on by the Dane County Dairy Promotion Committee and is the 41<sup>st</sup> Annual Breakfast on the Farm. It will be held June 8 from 7 a.m. to 11:30 a.m. Breakfast is free for ages 0-2, \$4.00 for ages 3-11, and \$8.00 for ages 12 and over. There will be music, entertainment and educational activities. The proceeds go to the Dane County Dairy Promotion Committee for other events and scholarships. They have reached out to local sponsors, and if anyone has any questions, please call her.

Kevin Klahn said it is good to highlight the Village and he invited members of the village board to be involved. Varney said there will be on-site parking, weather permitting, but they are looking for alternative parking and busing people to the site. Kirkpatrick mentioned the Brooklyn Elementary School and the Town of Brooklyn town hall. Legion Park was also mentioned as an alternative. They are hiring two county sheriffs to help with traffic and have rented signs from the DOT. Chief Engelhart offered Brooklyn Police Department services. The board thanked Varney and the Klahns for coming.

**Klahn made a motion to approve the April 8, 2019 minutes.** Kirkpatrick seconded. Motion carried. Rosenow abstained.

**President's Report** – Springer thanked everyone for coming to her first meeting as president.

**Safety Report – Chief's report** – There were a total of 101 calls, with traffic 119. Green County took six calls and Dane County eight. There were three open records, assisted fire/EMS twice, 10 parking citations issued for winter parking, 43 traffic calls, one crash, 9 other citations issued, 8 written warnings, 4 juvenile issues, 4 ordinance violations. They did a safety talk for the Girl Scouts and were judges at the school art fair. PD is participating in ongoing safety drills at the school with the fire department. Chief Engelhart, Officer Johnson, and Officer Kosharek were recertified in the Intoximeter. Johnson and Chief Engelhart went to dementia training, and Johnson attended a financial crimes against seniors training. They might start locking bathrooms in Legion Park at night due to some recent issues.

**Preliminary building plans for new business in Business Complex.** Chic Gladding, retired project manager, is assisting with the plans and brought preliminary plans. The initial building will be about 100 feet wide, 150 feet long, 22 feet high with a sloped roof. It will be a pre-engineered steel building. They plan to have a couple different colors to make it more appealing; the lower will be a lighter color and upper a darker color. It will be one giant open room because of the manufacturing processes. It will have an office, hallway and couple bathrooms. The building will sit closer to Prosperity Place. The lot slopes to the north, and the building requires a dock so trucks can unload steel, but not on a daily basis. To take advantage of the slope, they want to put the dock on the north end facing Highway 92. The company is also contemplating expansion in the future to the south. They will have masonry along the front, about four feet high. Kirkpatrick discussed the other phases of the Business Complex. It is zoned mixed use.

Gladding spoke with Josh Straka from Strand and Rob Roth, the zoning administrator, about what was needed. He talked about the placement of the building in relationship to the pond. Kirkpatrick's concern is the loading dock

facing 92, and if looking at the zoning code for the business park and the business across the street and where loading docks are, the loading docks are not front and center. She stated it's not exactly in the spirit of the ordinance, nor the precedent set on the other side. McCallum is okay if they put in screening. She's okay with the loading docks, if it makes sense for the business. If it's landscaped nice and they put in arborvitaes. It's so far removed from the road. They will be 300 feet back from the highway. Klahn said the docks are a concern for the appearance, but if the company can address it with arborvitaes or landscaping, he's okay with it. Kirkpatrick's concern is that's the front porch and we want it to look nice. The lots on 92 should be expect a different standard of appearance. We need to deal with it in such a way that the loading docks are not visible from 92. Springer asked what type of screen. Gladding talked about trees and arborvitaes. Kirkpatrick is okay with arborvitaes. It will be a physical barrier and it's aesthetically pleasing. Springer stated as long as it's an agreeable screening. Kirkpatrick is okay as long as the Village sees a plan for landscaping and it's approved. Shirley Pernot stated when they expand, there will be semis there on a more frequent basis. Rosenow asked if they expand, will there be more docks in a separate building. Pernot stated the north would be incoming and southeast side of the building would be outgoing. He said the plan was to have trees. Kirkpatrick thanked them for coming and being open to the discussion. Gladding stated they are working with MP Squared architects and Weiser Engineering.

Springer read the Treasurer's Week Proclamation, April 21-27. **Kirkpatrick made a motion to approve the Treasurer's Week Proclamation.** Klahn seconded. Motion carried. Springer read the Municipal Clerk's Week Proclamation, May 5-11. **McCallum made a motion to approve the Municipal Clerk's Week Proclamation.** Klahn seconded. Motion carried. Springer read the National Police Week Proclamation, May 12-18. **Klahn made a motion to approve the National Police Week Proclamation.** Kirkpatrick seconded. Motion carried. Springer read the Public Works Week Proclamation, May 19-25. **Klahn made a motion to approve the Public Works Week Proclamation.** Kirkpatrick seconded. Motion carried.

**McCallum made a motion to approve bills as presented.** Klahn seconded. Motion carried.

**Clerk's Report** – Village received the report from **Key Benefits** on the post employment benefit obligation needed for the audit. On April 17 Public Works was notified of a **sinkhole on S. Rutland**. The line was TV'd last week. A sewer lateral was capped for the empty property and they believe the cap failed. It was fixed today. They noted some breaks in the lines when they TV'd and he wanted board to be aware of it. Concrete work was finished on **S. Kerch Street**. McGuire said landscaping should be worked on next week, weather dependent, and asphalt after that. The deadline is May 17. **Stormwater basin expansion** in Business Complex is almost completed. The paperwork is being finalized for the **CWF loan**. Preconstruction meeting was on April 10 for the WWTP phosphorus upgrade project, with possible starting date of April 30. The first pay request is being given to DNR. The **Costa Rica representatives** came for their tour of the treatment plant on April 9. Spilde and Springer attended the **Arbor Day planting in Legion Park with the 4<sup>th</sup> Graders from Brooklyn Elementary**. A representative from DNR spoke to the kids as well.

Kirkpatrick stated she and Springer attended the **GCDC annual meeting**. The UniverCity people that did projects for Green County businesses and communities presented their results. They completed over 40 projects. She stated EDC will investigate working with the UW. There are some associated costs. Kuhlman asked for the **unallocated cash balance from the Fire/EMS** District Secretary so the board can be looking at it before the annual meeting. **DCCVA annual meeting** is May 1. We received the **annual report for the fire/EMS SAP program**. Kirkpatrick requested giving copy to all board members. Kuhlman sent a copy to the district secretary. Senator **Erpenbach is having listening sessions** on May 4. **Dumpster Days is May 10-19**. **Villagewide Garage sales** May 17-19. Assessors are sending out letters this week. **Open Book** will be May 22 from 12-3 and 4-7 p.m. and May 23, 9-noon and 1-3 p.m. **Board of Review** will be June 25 starting at 6 p.m. These dates have been posted on the website, Facebook and in the newsletter. Kuhlman was approached by Wanlesses about **possible annexation** of their property.

**Fire/EMS District Commission** -- Kuhlman attended the meeting on April 17. There will be no May meeting. **Next meeting will be June 19.** Chief's report was distributed. There was a new member in March and two more almost done with training. They had heating issues in the bay this winter. They are looking at the issue and will have a report for the board at the June meeting. Dan Dean went to a meeting at the Legislature. They have two new EMRs. They purchased a cradle point for the ambulance with association money. They covered for Albany for a period of time after Albany's license was temporarily suspended by the state. There will be a Dane County EMS meeting at the station on May 22. The SIM cards have been changed in all modems to the first responder priority network. Monona Plumbing will be doing an internal pipe inspection. They are hoping to have a meeting in May about combining the fire and EMS. Financial reports were distributed by the district secretary. They reviewed their social media policy.

Klahn questioned combining the departments. By state statute we have to have fire but we don't have to have EMS. If combined, we're locked in. There needs to be more of a county effort, rather than just the local municipalities. We need full-time staff and none of the communities can afford to staff their own. We need more central hubs and satellites. McCallum stated the benefit would be to have more people trained in both services so there would be more accessibility to performing the functions because you have more people there. They already have some cross-trained. Kirkpatrick stated the cross-pollination can be done without merging. McCallum thinks it would be the most efficient to combine with an initial head and captains down the chain. When started talking about this the commission would like to hire the head and assistants or combine service, and the commission would hire, instead of members appointing the heads of the departments, to make the service more professional. Barber actually handed in a resume before being elected by the members. The committee is 3 people from each service and 2 commissioners. They will discuss how it would work. Kirkpatrick stated municipalities should be asked also. Klahn said he would like to see the pluses and minuses of both sides of the argument and the hierarchy. McCallum said they will be exploring options and it will come back to all municipalities. McCallum asked if the board wants to join in the discussion from the legislation regarding fire and EMS districts. Board requested it be included on the next agenda so trustees could read the letter.

**Klahn made a motion to adjourn at 8:26 p.m.** McCallum seconded. Motion carried.
